**1. Consideration of Meeting Minutes: 7/3/08 Commission minutes**, moved, Paul Bennewitz, seconded Cyndi Newburn, unanimous approval without changes.

**2. Presentation by Mark Sorenson, Metro Transit (Consultant) / Dawn Coomer, COT Transportation Planner.** Quick and comprehensive Power Point slide show review of the many transit options studied for the 24 month South Tempe Corridor study, as required by the federal planning process seeking public comment on all options being considered. These options include several combinations of bus and rail transit possibilities and bus only options to move riders north to the downtown core areas to intersect with the new light rail system and with the ASU main campus. It will be some 2 more years before the final option is in place, with multiple steps through the Tempe City Council, as well as approvals through the Maricopa County Association of Governments (MAG) and the Valley Metro. Regional Public Transportation Authority (RPTA).

**3. Presentation by Jason Hartong (on behalf of Greg Jordan), COT Transit Operations Coordinator.** Power Point slide show presentation about the various local Tempe bus routes and schedule changes being put into effect by Valley Metro RPTA (on or before the date) when the new light rail system begins operation on December 27, 2008. Also presented were any changes to the routes and schedules for the ASU Flash and the COT Orbit neighborhood bus systems. Comments by Commissioner Newburn regarding the ongoing lack of ANY free

neighborhood transit services (Orbit) south of Highway 60 was duly noted by Mr. Hartong. He explained that this continues to be an issue related to an ongoing lack of funding to expand Orbit routes, not an oversight by the City of Tempe.
