COMMENTS: This is a resolution amending the City Code Appendix A, Schedule of Fees and Charges. The amendment will increase fines for violations of Chapter 21, Nuisances and Property Enhancement by \$50 per violation, the first increase in the overall fine schedule in five years. A separate fine is also included for persons deemed to be Habitual Offenders to deter future violations and to aid populations in need of services.
