ADDITIONAL INFO: The State of Arizona issued a solicitation and awarded a contract for the purchase of Information Technology Research and Advisory Services with Gartner, Inc. which has cooperative language allowing other agencies to use the contract. This contract will provide the Information Technology Department with access to consultants, advisors and research teams, as well as customized research reports, webinars, and consultant advisory services. Staff recommends approval to utilize the State of Arizona contract for information technology research and advisory services.

Gartner, Inc. Service Agreement for City of Tempe, AZ ("Client")

This Service Agreement ("SA") consists of Sections 1 and 2 below, as well as the terms and conditions between the State of Arizona, and Gartner, Inc. in accordance with Contract #AD990090-001-A19, dated December 31, 2007. This SA constitutes the complete legal agreement between Gartner, Inc. of 56 Top Gallant Road, Stamford, CT 06904 ("Gartner") and Client for the Services described herein, and shall be effective when signed by Client and Gartner. Client agrees to subscribe to the following Services for the term and fees set forth below.
