RENEWAL

This Renewal is made and entered into by and between Kyrene School District No. 28 (District) and the City of Tempe (City), and renews the original agreement known as the Intergovernmental Agreement Between the Kyrene School District No. 28 and the City of Tempe for the Provision of Before School, After School and Summer Snacks and Breakfasts for the Kid Zone Enrichment Program, Tempe agreement number C2005-85 (Agreement), made and entered into by and between the District and the City on or about May 10, 2005 and recorded with the Maricopa County Recorder's Office on May 26, 2005.

For and in consideration of the mutual covenants and conditions hereinafter contained, it is agreed by and between the District and the City as follows:

1. Pursuant to Section 2, Duration, of the Agreement, the District and the City herewith confirm their mutual agreement to renew this Agreement for one (1) year beginning on July 1, 2008 and continuing through June 30, 2009.

2. All other provisions of the Agreement where not inconsistent with this


Renewal shall remain binding on the parties hereto.
