

RESOLUTION NO. R2017.146

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPE,
ARIZONA, AMENDING TEMPE CITY CODE, APPENDIX A, THE
SCHEDULE OF CHARGES FOR WATER IRRIGATION SERVICE
PURSUANT TO TEMPE CITY CODE SECTION 33-74**

WHEREAS, Tempe City Code, Section 33-74, authorizes the establishment of charges for providing water irrigation service; and,

WHEREAS, the City of Tempe, after due consideration and diligence, has deemed it prudent and necessary to revise those charges.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA, AS FOLLOWS:

That the following schedule of charges for water irrigation service is established, effective January 1, 2018, and shall be set forth in Appendix A of the Tempe City Code:

33-74 Irrigation Rates

- (a) The following fee structure shall be established for irrigation service rates effective JANUARY 1, 2018 ~~November 1, 2005~~:

34,849 plus	\$405.68 plus \$50.71 per each 4,355 square foot increment or portion thereof in excess of 34,848 square feet

34,849 PLUS	\$442.19 PLUS \$55.27 PER EACH 4,355 SQUARE FOOT INCREMENT OR PORTION THEREOF IN EXCESS OF 34,848 SQUARE FEET


~~(b)~~ The costs associated with the irrigation of city facilities will be billed at a rate equal to the annual job cost charge for irrigation services.

~~(b)~~ (c) An administrative fee of \$15.00 will be charged to establish service.

~~(c)~~ (d) A service charge of \$75.00 will be assessed to any customer for unauthorized use of irrigation services, for each occurrence. In addition, charges for water delivered will be assessed.


~~(d)~~ (e) Applicable taxes or governmental impositions which are assessed on water sales shall be added.


