



Request for reproduction of lists and information derived from data received electronically from the Maricopa County Recorder/Elections Department

Terms and Conditions: MARICOPA COUNTY ELECTIONS DEPARTMENT VOTER LISTS, REGISTERS AND FILES CONTAIN RESTRICTED DATA - RELEASE OR DISTRIBUTION OF ALL OR ANY PORTION OF SUCH INFORMATION IS RESTRICTED AND IN SOME CASES PROHIBITED BY LAW, SUBJECT TO CRIMINAL PROSECUTION.

Data contained on electronic media and paper provided to the City of Tempe containing voter registration files, lists or reports are derived from the County's General Register. The data is the property of the Record Custodian, Maricopa County Elections Department. Pursuant to Arizona law, the data is subject to protections and restrictions. Release, distribution or use of this information is prohibited except by Maricopa County and as disclosed in written request to the Maricopa County Record Custodian, or pursuant to A.R.S. §16-168D, or pursuant to written authorization by the Record Custodian approving release or distribution to, or use by, anyone other than the original requester, or to any person or for any purpose not stated or disclosed in the original request. Persons using this information for any purpose except those authorized by law are subject to fine and/or imprisonment. Furthermore, any person who obtains this data for a commercial purpose without indicating the commercial purpose, or any person who uses or knowingly allows the use of this record for a commercial purpose, or for a different commercial purpose than originally stated, or who obtains this data from anyone other than the Custodian of the Record and uses the information for a commercial purpose, is liable to the County for treble damages and attorney fees, in addition to penalties provided by law.

The data provided to the City of Tempe may be distributed to candidates and political action committees who make such public record request in accordance with the law. However, the requester shall sign and agree to the terms and conditions of this agreement.

I agree to the following terms and conditions to receiving data electronically:

1. Voter data is sought for an authorized use.

Precinct registers and other lists and information derived from registration forms may be used only for the following purposes:

- relating to a political or political party activity,
- a political campaign or an election,
- for revising election district boundaries or
- for any other purpose specifically authorized by law.

Any person in possession of a precinct register or list, in whole or part, or any reproduction of a precinct register or list, shall not permit the register or list to be used, bought, sold or otherwise transferred for any purpose except for uses otherwise authorized.

2. Voter data will not be used for a commercial purpose. These records may not be used for a commercial purpose as defined in A.R.S. § 39-121.03. The sale of registers, lists and information derived from registration forms to a candidate or a registered political action committee for a use specifically authorized by this subsection does not constitute use for a commercial purpose.

3. Internet Posting is Prohibited. A person in possession of information derived from voter registration forms or precinct registers shall not distribute, post or otherwise provide access to any portion of that information through the internet.

4. Charge for Records. There is a \$10 per CD/USB charge.

5. The following voter data will be redacted:

- the month and day of birth date,
- the social security number or any portion thereof,
- the driver license number or non-operating identification license number,
- the Indian census number,
- the father's name or mother's maiden name,
- the state or country of birth

- the records containing a voter's signature
- voter's email address.

6. Unredacted voter data will be accessible to, or reproduced, only for the following individuals:

- the voter,
- an authorized government official in the scope of the official's duties,
- for any purpose by an entity designated by the Secretary of State as a voter registration agency pursuant to the national voter registration act (NVRA)
- for signature verification on petitions and candidate filings,
- for election purposes and
- for news gathering purposes by a person engaged in newspaper, radio, television or reportorial work, or connected with or employed by a newspaper, radio or television station or pursuant to a court order.
- **However, notwithstanding any other law, a voter's e-mail address may not be released for any purpose.**

A PERSON WHO VIOLATES ANY OF THESE PROVISIONS, AS SET FORTH IN A.R.S. §16- 168(E) AND (F) IS GUILTY OF A CLASS 6 FELONY.
