**Vice Chair Arlene Chin** called the meeting to order and invited members of the public to address the Commission.

**Agenda Item 2 –Consideration of Minutes**

**March 11th, 2008**

Commissioner Fentress Truxon had a change to the March minutes.

**Agenda Item 3 – Hate Crimes Update**

Chief Tom Ryff first introduced Charles Cobb, Community Affairs Specialist for the Police Department. This is a new position for the police department and will be a direct contact for the public. Mr. Cobb introduced himself and shared some background about himself and his previous experience.

Sergeant Scott Smith gave an update on the offensive literature issue discussed at the February meeting. The individual has been identified and there are two active aggravated assault cases, one in Mesa and the other in Scottsdale. The Tempe incident will be used as aggravated circumstances for sentencing.

City Attorney Andrew Ching previously met with Commissioner Truxon and Chief Tom Ryff and members of the Police Department to discuss Hate Crime legislature. Andrew Ching provided the commission some history behind the current legislature. He stated that basically you "can't ban a message just because you don't like the message, but you can ban expressive conduct when there is intent to threaten". In Arizona, hate crime distinction is used as a sentence enhancement.

Commissioner Truxon thanked everyone for meeting with him. He has also asked the AZ Civil Rights Advisory Board to review the issue on their level.

#### **Agenda Item 4 – Jewel in the Desert Exhibit**

Ginny Belousek briefed the commission on an upcoming event celebrating the Muslim community. The Jewel in the Desert Committee has been meeting monthly. The event is centered around an art exhibit that will be on display at City Hall. It will start at the end of Ramadan on October 3<sup>rd</sup> with a invite only reception and open house at the Mosque. On Saturday, October 4<sup>th</sup>, there will be a Muslim cultural street festival at 6<sup>th</sup> Street Park.

#### **Agenda Item 5 – Exhibits on African American Community**

Rosa shared with the commission information about past exhibits showcased on the African American community. The first was took place in 1999 in connection to the first MLK Diversity Awards, the second was an exhibit titled "Beloved Community" which has been donated to the Washington Carver Museum in Phoenix. Amy Douglass, Museum Administrator, is now working to update the Tempe history movie and it will highlight a more diverse history within Tempe.

#### **Agenda Item 6 –Inclusive Sign**

Rosa informed the commission that the original inclusive sign was donated by National League of Cities. The sign was taken down due to deterioration. City Manager Charlie Meyer has requested that multiple new signs be put up at various city limit points. Alan Domsy is in the process of developing the new sign and Rosa shared some mock ups with the commission.
